Southern California Nevada Conference Annual Gathering 2021 "Flourishing in Love" - (conducted via Zoom) MINUTES

Friday, June 11, 2021 - Session 1

Opening Worship

Moderator Rachel Chapman welcomed attendees at 6:00 PM and the gathering began with a service of worship featuring beautiful musical offerings and liturgical contributions from various members of the conference and a powerful sermon by the Rev. Dr. Jacqui Lewis, Senior Pastor of Middle Collegiate Church in New York. An online offering was received throughout the gathering to support Tougaloo College in Mississippi (a Historically Black College related to the UCC), Pilgrim Pines Camp, Our Church's Wider Mission, and the UCC Disaster Response Ministry.

Call to Order

Moderator Rachel Chapman called the first business meeting to order at 6:44 PM.

Guests Rev. Richie Sanchez - Regional Minister, Pacific Southwest Region Christian Church (Disciples of Christ) and Rev. Nancy Brink - Director of Church Relations, Chapman University were welcomed.

Past Moderator Rev. Megan Owens gave instructions on delegate credentials and online voting procedures.

Declaration of Quorum

A quorum was declared with 42 lay delegates and 59 clergy delegates. 59 visitors were also in attendance and 66 churches were represented.

Approval of 2021 Annual Gathering Agenda

The 2021 agenda was approved.

Approval of 2020 Annual Gathering Minutes

The 2020 minutes were approved.

Invitation to New Business

Moderator Rachel Chapman asked for any new business to be presented for consideration at Annual Gathering at this time. No new business was presented.

SCNC Board Chair Report

Conference Board Chair Rev. Sarah Averette-Phillips reported on the board's work over the past year. She highlighted the reality of change we have all faced during the Covid-19 pandemic. The board, like most churches, has conducted its work virtually via Zoom, email, etc. She noted that increased accessibility and availability have been positive outcomes of this virtual work.

During the past year the board has accomplished its basic functions including oversight of conference properties including Pilgrim Pines Camp, budgeting, making statements on issues of justice, and working to support local clergy. A large part of the board's year has been spent navigating conference needs during the leave of absence of Conference Minister Rev. Felix Villanueva due to a fitness review and his recent retirement. Rev. Averette-Phillips expressed her gratitude on behalf of the board for the work of Acting Conference Minister, the Rev. Libby Tigner, Associate Conference Ministers, Rev. Kris Bergstrom and Rev. Rudy Van Graan, and the whole conference staff.

Rev. Averette-Phillips celebrated the growing diversity of social locations of board members to be elected to service this year. She then went on to highlight some of the work the board will be tasked with in the coming year including reassessing the conference's purpose, working on the mission and vision, identifying a transitional conference minister, supporting the search process for a settled conference minister, and supporting local churches.

Saturday, June 12, 2021 - Session 2

Worship

Call to Order

Moderator Rachel Chapman called the meeting to order. Past Moderator Rev. Megan Owens gave an overview on delegate credentials and online voting.

Acting Conference Minister Report

Acting Conference Minister Rev. Libby Tigner began her report with a recognition of the Rev. Felix Villanueva's eleven years of ministry as Conference Minister upon the occasion of his retirement in June 2021. She highlighted his work with local churches aiding in search and call, strategic planning, and conflict management, as well as his time spent representing the conference in a variety of wider church and community settings. She invited the gathering to join her in wishing him well in his retirement.

Rev. Tigner offered her gratitude and commendation for the ways local churches, the conference, and Pilgrim Pines Camp have continued to minister and thrive in the era of Covid-19 including online worship, social justice work, virtual camp, service ministries, and more. And she recognized how these experiences have taught us all lasting lessons that will inform future ministry. She offered a special thank you to our hospital chaplains for their important and difficult work during this time.

Rev. Tigner gave an overview of the evolving work of the conference staff team. Both Associate Conference Ministers Rev. Kristin Bergstrom and Rev. Rudolph Van Grann have special responsibilities in addition to supporting basic conference functions. She also highlighted the work of Youth and Young

Adult Coordinator, Mary Traylor and the integral work of Virginia Arroyo and Stella Perez at the conference office.

Report on 2020 Annual Gathering Resolutions

Moderator Rachel Chapman reported on the progress made in the last year on the two resolutions passed at the 2020 Annual Gathering:

RESOLUTION TO END POLICE BRUTALITY AND SYSTEMIC RACISM AGAINST BLACK PEOPLE IN AMERICA This was an emergency resolution of witness, meaning no action items were assigned to it. Our conference staff started a weekly zoom call called Conversations on Race which is ongoing with 20 or more in attendance.

RESOLUTION OF AFFIRMATION FOR THE SOUTHERN CALIFORNIA NEVADA CONFERENCE OF THE UCC TO BECOME AN "ACCESSIBLE TO ALL" CONFERENCE

The Conference Accessibility Team has been working with local churches and conference staff to complete the requirements of inclusion and accessibility. On May 29th, UCC Disabilities Ministries granted our conference the designation of Accessible to All. Our ASL Interpreters, closed captioning and larger print are just some of the accommodations that will continue.

Revision of Conference Bylaws

Rev. Libby Tigner gave an overview of the proposed changes to the bylaws and answered questions from attendees regarding these changes (see below).

On behalf of the SCNC Board of Directors, Rev. Tigner moved that the revision to Article IX, paragraph 26, section a, lines 292-294 of the SCNC Bylaws be approved (no second needed, as the motion came from the board of directors).

Motion passed: 109 yes, 0 no, 3 abstentions

On behalf of the SCNC Board of Directors, Rev. Tigner moved that the revision to Article X, paragraph 30, lines 398 and 399, and paragraph 31, lines 410 through 412 of the SCNC Bylaws be approved (no second needed, as the motion came from the board of directors).

Questions were answered regarding how decisions are made at the board level, how the board chair and other officers are selected (via the nominating committee), that the Conference Minister will no longer be considered an officer of the corporation (board chairperson, secretary, and treasurer are officers). The intention is to align with our congregational polity and move away from corporate language (which would be in keeping with common practice in other UCC conferences).

Pilgrim Pines Camp and Outdoor Ministries Report

Rev. Petra Malleis-Sternberg and Mary Traylor reported on the work of the Outdoor Ministries Team and

the ministries of Pilgrim Pines Camp over the past year. They shared reflections from participants on the innovative virtual camp and camp-in-a-box programs that were produced this year when in person camp

was suspended due to the pandemic. They shared plans for the future which include both in person and

virtual offerings and celebrated the increased accessibility of virtual camp opportunities. They extended

their gratitude for the Youth and Young Adult Team (YAYA), the Outdoor Ministries Team, all volunteers,

staff, and members of local churches who have made these ministries possible.

New/Emergency Resolutions

No new or emergency resolutions were submitted for consideration.
